# Special Diets Frequently Asked Questions 

1. I think my child has an allergy to certain foods but I am not sure. What should I write on the form?
If you think your child has a food allergy we strongly advise you to seek the advice of a medical professional to obtain further information as soon as possible.
2. I have already told you verbally about the food allergy, why do I need to fill in the form?
We need to keep a written record with details of any food allergies to ensure the Catering department have accurate information about your child's allergy. We can also share it in an emergency with medical professionals
3. My child requires a specific cultural or religious diet, should this be detailed on the form?
There is no requirement to complete the form, we believe our menu offers a diverse range of foods to cater for all.
4. My child has a packed lunch. Do I need to complete the form?

You do not need to complete this form. The contents of your child's lunch box is your responsibility. However if you would like your child to participate in Theme days/Christmas Dinner you will need to complete the form.
5. Providing and sharing medical information on my child.

Allergen data is considered health data and under the GDPR this is a special category of data which has specific requirements. It is only with explicit consent, from parents/guardians it is permitted under GDPR to process the allergen data we receive from you.
